

**IMPORTANT INFORMATION REGARDING NEW SERVICE OR CHANGE OF SERVICE**

Welcome to Stanton County Public Power District. If you have previously been a customer of the District you may not have completed this form with a previous change of service. However, in accordance with the Red Flag rules amendment to the Fair and Accurate Credit Transaction Act (FACTA) provisions of the federal Fair Credit Reporting Act (FCRA), we are now required to collect additional information to begin or change your electric service with Stanton County Public Power District. In our continuing efforts to provide the most efficient and accurate service we have recently started utilizing a program, called ONLINE Utility Exchange, to determine meter/security deposits. Using your information the program determines your credit risk and therefore provides a rating of "RED", "YELLOW", or "GREEN". The green light rating indicates no credit risk and will require no deposit. The yellow light rating indicates low credit risk and will require a deposit equal to 1.5 times the average monthly bill for the service address. The red light rating indicates high credit risk and will require a deposit equal to 3 times the average monthly bill for the service address.
